Format:

- All Singles events are round robin for the first round. Subsequent rounds will be single elimination. **Except for U 2350 Singles**
- **Top 2 players** from each group in the first round will advance to the next round
- All Doubles events are single elimination.
- All matches are 11 points best of 5 games, except for the final match of Open Singles, which will be best of 7 games.
- USATT rules and regulations will be enforced.

Event: Player may be removed from an event at any time should the Tournament Committee decide that the player is overqualified. The Tournament Committee also reserves the right to cancel any event if there are insufficient entries. Fees will be refunded for any cancelled events.

Equipment: Only USATT approved equipment will be used; STIGA tables and white Butterfly 3-Star balls will be used. Floors are hard wood.

Ratings: For event eligibility, the 09/01/2013 USATT web site published ratings will be used. Seeding will be based on most current ratings.
